Regardless of the form of payment, acceptance of this application by Montessori Academy at Spring Valley constitutes a contract for the duration of the school year. The entire year's tuition will be due and payable even in the event that the student does not complete the school year for any reason.

In case of a move, a 30-day written notice is required. Otherwise, a whole month's tuition will be due. Any release of this obligation must be executed, in writing, by Montessori Academy at Spring Valley.

Tuition is due the 1st of each month. If payments are not received by the 5th of the month, there will be a **\$50 late charge monthly.** Payments not received within 60 days of their due date shall result in the immediate dismissal of the student. A fee of **\$50** will be charged for **NSF checks.** A fee of **\$4.00 per minute** will be charged beyond 6:00 p.m. for **late pick up.**

In the event that this contract is referred to any attorney for collection, those responsible for tuition hereunder agree to pay all costs incurred in the collection of such debt, including costs and a reasonable attorney's fee.

Please attach a check for registration: **returning students - \$200** (by March 30, 2017), **\$250** thereafter; **new students - \$250**. Registration fee is non-refundable and cannot be deducted from tuition payments.

As stated in the Parent-Student Handbook, there is a probationary period of 30 days for new students. Permanent status begins after 30 days trial period.
